Have You Noticed Color-Coded Lanes?

Did you know that some sections of the roads in our community are painted in colors other than white or yellow? Here, we would like to introduce some of the colored roads you might see in familiar places.

Green Belt



As a safety measure for school-commuting, the roadsides are painted green to alert passing vehicles. We expect that drivers pay attention to the pedestrians on the road.

ZONE 30

Misato City implements a regulation of speed limit of 30 km/h on the residential roads.

'Zone 30' is an idea that treats multiple roads in a residential area as a unified system, implementing a uniform speed limit of 30 km/h on all roads within the area; thus, it prioritizes pedestrian traffic and aims to minimize through traffic as much as possible.

When you drive in this zone, you must observe the speed limit of 30 km/h and drive slowly.

CITY NOTICE

(From February 2026 to April 2026)

1. Request for Compliance with Tax Payment Deadlines

1. If you fail to pay your taxes by the due date

① Addition of Delinquent Charge

Delinquent Charge will be added from the day after the due date.

② Demand Letter

A demand letter will be sent if the payment deadline passes. It is a legal requirement to send a demand letter to those who have not paid.

③ Investigation of Assets (Savings, Salary, Life Insurance, Pensions, Accounts Receivable, Real Estate, etc.)

- The assets of delinquent taxpayers will be investigated. This includes inquiries with financial institutions, insurance companies, employers, contractors, and business partners.
- Asset investigations are necessary not only for seizure purposes, but also to determine the taxpayer's ability to pay.

④ Seizure of Assets

If payment is not made in full within 10 days from the date the demand letter was sent, we will seize your assets to ensure fairness with those who paid on time. Seizure means prohibiting the transfer of assets and placing them in a state available for liquidation (forcibly converting the seized assets into cash).

⑤ Information about the Sunday Tax Payment Counter

The tax payment counter is generally open the 2nd Sunday of each month. This may change due to circumstances, so please call us or check the website in advance.

⑥ FAQ

Q1: What should I do if I cannot pay by the due date?

A: If you have special circumstances that prevent you from paying, please contact the Tax Collection Division before the due date.

Q2: Can a demand letter be sent or assets seized even if I am making installment payments?

A: Even if you are making installment payments, delinquent charge will be added, demand letters will be sent and assets will be investigated and seized.

Q3: If my wages are seized, will the full amount be collected?

A: If your wages are seized, the full amount will not be collected. The amount of your wage, minus the amount prohibited from seizure (applying Article 76 of the National Tax Collection Act), will be collected from the payer of your wage and will be applied to the delinquent tax. Collection will continue monthly until the delinquency is resolved.

2. Please pay your National Health Insurance Tax by the due date

National Health Insurance is a system in which subscribers (insured persons) pay insurance tax to collectively subsidize medical expenses so that you can see a doctor without worry when you get sick or injured. Insurance tax is an important source of funding for the National Health Insurance system covering your medical expenses and plays a very important role. If insurance tax is not properly paid, the system cannot be maintained stably.

A prior notice will be sent to long-term delinquents regarding the change to the payment of 'special medical care expenses,' and medical their expenses may temporarily need to be paid in full on their own account. Therefore, please make your payment of the health insurance tax by the due date.

3. Please use the easy and convenient bank account transfer service to ensure you never miss to pay your taxes

- Once you complete the procedure, your transfer will be automatically renewed for the following fiscal year, making it extremely convenient.
- Please bring your 'tax payment notice,' 'savings passbook', and 'seal (passbook registration seal)' directly to a financial institution designated by the city.
