	Be sure to visit and confirm that you agree with the childcare policies of the institution(s) to which you are going to apply for admission. Especially child care institutions other than municipal ones may have special missions and policies about childcare and they may charge you an extra fee (e.g., at a private child care center: expense for an uniform, educational materials and/or parents' association and so on; at a Certified Centers for Early Childhood Education and Care (ECEC Center) [Nintei Kodomoen]: fee for entrance preparation <approx. 50,000 - 150,000 yen depending on an institution> for a child who is admitted in a 3-year-old or elder class, besides the expense for a uniform or the fee for educational materials) in addition to the child care fee specified by Misato City. Among the reasons of employment, if you fall under any of the following work categories: executive, self-employed, self-employed full-time worker, family full-time worker, home worker, or contract worker, and if the certificate of employment is provided by yourself or your family members, you will be required to provide a separate certificate (Business license, notification of opening of business, copy of contract/order documents, etc.). 	<p>Notice of result of admission in April will be sent out in February. 	<p>Misato Shirayuri Hoikuen, Waseddako Chuo Hoikuen, other small child care institutions and child care institutions in the workplace are available until 2-year-old classes. 	Job seeking/ Prospective employment 求職活動・就労内定	3 months 3か月間	Submit a 'Change in Approval on the necessity of childcare service' and 'Certificate of employment' stating 64 actual working hours or more within 3 months from your child's admission.  入所から3か月以内に実働月 64 時間以上であることが確認できる『就労証明書』及び『支給認定変更申請書』を提出する。
	If you apply during your childcare leave, you are required to return to work at the 'workplace that issued the Certificate of Employment' with the same employment contract hours as when you apply (but the short-time work system is acceptable) in order to continue using the childcare service. (If you are a temporary employee and are scheduled to work at a different workplace after returning to work, please adjust your work days and hours so that the conditions are the same as at the time of your application. 	If you are approved the necessity of child care due to a reason of 'Employment', you must meet the criteria to use a child care institution with actual monthly work of 64 hours or more per month (regularly). Therefore, if your actual monthly work continuously becomes less than 64 hours, even if it is due to nursing care of your sick child etc., your child must leave the child care institution as your necessity of childcare service does not meet the criteria. 就労の事由により入所している方は、毎月(常時)実働64時間以上就労する必要があります。お子さんの体調不良等が理由であっても、実働64時間を下回る月が続く場合は退所となります。		<input type="checkbox"/>

After admission 保育施設入所後	<p>If your elder child is already attending a child care institution and you are taking a childcare leave for the younger one, the approval period of the elder one will be until the end of the fiscal year (March 31) that includes the day the younger one turns 2 years old. (Taking into consideration an acclimation period of your younger child to get accustomed to new environments at a licensed child care institution, etc., you need to end your childcare leave and return to work by May 1 of the following fiscal year. Childcare fee 保育料	<p>The child care fee is payable each month. Please be sure to pay by the due date. Even if your child withdraws from the institution in the middle of the month, you will be charged a half of the childcare fee until the 10<sup>th</sup> of the month and the full amount after the 11<sup>th</sup> of the month.</p> <p>保育料は1か月単位でご納付いただきます。納期限までに必ず納付してください。月の途中で退園しても、月の10日まででは半額、11日以降は全額の保育料がかかります。</p>	<input type="checkbox"/>
	<p>If Misato City cannot confirm the municipal resident tax of the person under duty to support the child (because the person has not declared the Municipal Resident Tax, or if the resident tax certificate for a new resident has not been submitted), the highest childcare fee will be charged.
